EPA Lead Renovation, Repair and Painting Rule (RRP) went into effect April 22nd, 2010.

Are You Certified To Comply With The New Law?

Compliance is necessary before performing any work that meets these criteria:

- Disturbs a painted area (interior or exterior) in excess of 2' x 3' and
- Structure was built before 1978 and
- Structure is a home or residential building or
- Structure is occupied by children (school, child care facility)

Who Should be Certified?

All contractors who engage in projects that could potentially disturb paint are expected to comply. These include plumbers, painters, carpenters, electricians, remodelers, installers, repair specialists and other trades people.
